Contra Costa County, Richmond, Rodeo Hercules and El Cerrito Firefighters responded to a report of a residential structure with the owner trapped in El Sobrante. Contra Costa County Fire Dispatchers were on the phone with the resident of the home who was reporting the fire. The resident stated the fire was in the living room and she was trapped. The dispatcher stated the resident was no longer talking on the phone. Based on this report, the incident was immediately upgraded to a 2nd alarm response by Con Fire Dispatchers.

Engine 69 (EL Sobrante) arrived on scene and reported heavy fire from the front door and front window of a two story home. Engine 69 assumed command and Engine 70 who arrived on scene with E69 assumed fire attack and searched for the trapped resident. BC7 assumed command and all companies were assigned to support the rescue and fire attack. Truck 70 was assigned ventilation and the tactic of Vent-Enter-Isolate-search through the front second story window. The victim was located and rescued on the first floor by the crews of Engine 69, 70 and 66. The Engine crews removed the unconscious victim through the front door. The victim was in cardiac arrest, Firefighter-Paramedics initiated immediate Advanced Life Support. The main body of the fire was knocked down by the initial crews while Truck 70 completed roof top ventilation. There were no Firefighter injuries. The cause of the fire is under investigation. At the time of this report, the victim was at Kaiser Richmond and being transferred to UC Davis Burn Center for specialty care.
