PUBLIC HEARINGS

A. October 8, 2025 Report on the Cost of Abatement

Chair Thompson opened the public hearing on the October 8, 2025, Report on the Cost of Abatement. Hearing no objections or protests to the October 8, 2025 Abatement Report, the hearing was closed. COMMISSIONERS' COMMENTS / ITEMS FOR FUTURE AGENDAS

Commissioner Egan inquired about the status of upcoming Captains testing within the District. Deputy Chief McAlister reported that both Captains and Engineers promotional testing will be conducted in the near future.

Commissioner Thompson inquired about the District's plans for the future of lawns at fire stations. Deputy Chief McAlister stated that the District is exploring suitable and sustainable landscaping options that could serve as a model for homeowners. Commissioner Thompson expressed that she would like to see the lawn at Station 11 in Clayton retained to help keep the Annual Fallen Firefighter Memorial visitor-friendly, as community members often walk through the flag display and read the personalized cards honoring the fallen firefighters of 9/11.

Commissioner DeMarce commented on his experience volunteering at the District's Annual Open House. He stated that the community members he interacted with were appreciative and appeared very pleased with the event and the addition of the free pancake breakfast. He noted that the event was well attended and considered it a great success.

Commissioner DiPrisco recognized and commended the District for its actions during the fire on Pleasant Hill Road in Lafayette, noting the effective use of both ground and aerial resources.

Commissioner DiPrisco thanked the District for providing a fire truck for the Rotary Club of Lafayette's Keep on Truckin' event, which was attended by over 1,300 community members.
